

**SETTING THE FEES TO BE PAID IN RANDALL COUNTY FOR
SERVICE OF CIVIL PROCESS AND SETTING OTHER
SHERIFF'S AND CONSTABLE'S FEES HEREIN
SPECIFIED AS PROVIDED BY LOCAL
GOVERNMENT CODE SECTION 118.131**

BE IT REMEMBERED that at a meeting of the Randall County Commissioners Court, the following order was adopted:

WHEREAS, Local Government Code Section 118.131 authorizes the Commissioners Court of each county to set reasonable fees to be charged for services by the offices of Sheriff and Constable; and

WHEREAS, an analysis of the projected costs of serving judicial civil process for the year 2023 has been prepared and a determination made as to the level of fees required to recoup the costs to Randall County for service; and

WHEREAS, the Commissioners Court is of the opinion that the following fees are reasonable and should be established for service of civil process in Randall County, Texas, effective January 1, 2023.

NOW THEREFORE, the Commissioners Court of Randall County, Texas sets the following fees to be charged for each person, corporation or legal entity on whom service of any of the below listed process, or process not otherwise provided for, is performed or attempted and return made:

Service, or attempted service, of any civil process or order not otherwise provided for, a fee of \$100.00.

For posting of Notice of Sale of Property on a Writ of Execution, a fee of \$25.00 for each location.

For executing any Writ or Order of Sale past two hours, an additional fee of \$50.00 per hour, per deputy, due at time of service, plus \$90.00 each additional day and \$0.60 per mile for travel, round trip, outside of Randall County.

For executing or attempting to execute any Writ not otherwise specified, all courts, a fee of \$200.00.

For posting written notices in public places, as may be required by law, a fee of \$100.00 for each location.

For executing a deed to each purchaser of real estate under Execution or Order of Sale, when demanded by the purchaser, a fee of \$40.00.

For executing a Bill of Sale to each purchaser of personal property under Execution or Order of Sale, when demanded by the purchaser, a fee of \$40.00.

Commission for collecting money on Execution, Order of Sale, Bill of Cost, or a Turnover Order, a fee of five percent (5%), with or without a sale.

For each civil case tried in a District or County Court at Law, a bailiff's fee of \$5.00.

IT IS THEREFORE ORDERED by the Randall County Commissioners Court that the fees as prescribed above are hereby set to become effective January 1, 2023 and shall remain in effect until further orders of this court.

IT IS FURTHER ORDERED that the District and County Clerks, the Justice Courts, and any other affected official or department make appropriate revisions of their fee schedules and deposit requirements to incorporate therein the above fees prescribed by this Court.


